- 4) The basis for the processing of personal data is:
  - Art. 6 para. 1 lit e) of the General Data Protection Regulation of 27 April 2016 (GDPR), in conducted on the basis of Article 111 of the Act of 20 July 2018 on Higher Education and Science, the statute of the Silesian University of Technology.
  - Art. 6 para. 1 lit. a) of the General Data Protection Regulation of 27 April 2016 (GDPR) in the case of an image.
- 5) Personal data will be stored during the period of membership in SKNCh and after leaving the Association for the purpose of archiving and keeping the Chronicle of the Association.
- 6) In the case of personal data processed on the basis of consent (image), you have the right to withdraw consent at any time without affecting the lawfulness of the processing, which was made on the basis of consent prior to its withdrawal.
- 7) You have the right to request access to the content of your data and the right to rectify, delete, limit processing, lodge an objection.

- 8) You have the right to lodge a complaint with the President of the Office for Personal Data Protection when you consider that the processing of your personal data violates the provisions on personal data protection.
- 9) Based on the personal data provided, the Administrator will not make automated decisions against you, including decisions resulting from profiling.
- 10) Providing data is voluntary, however, refusal to provide them results in the inability to participate in the activities of SKNCh.
